REGULATIONS

of the Educational Project "The Pilecki Project"

General provisions

§1.

- 1. These regulations, hereinafter referred to as the "Regulations", set out the rules for the organisation of the educational project "The Pilecki Project", hereinafter referred to as the "Project", organised by The Witold Pilecki Institute of Solidarity and Valor with its seat in Warsaw at ul. Foksal 17, 00-372 Warsaw, a research institute entered into the register of entrepreneurs of the National Court Register kept by the District Court for the Capital City of Warsaw in Warsaw, 12th Commercial Division of the National Court Register under the number KRS 0000713483, NIP 5252735962 and REGON 369236544, hereinafter referred to as the "Institute" or the "Organiser".
- 2. The aim of the Project is to raise interest of pupils and students living in the USA and Canada, hereinafter referred to as the "Participants", in the latest history of Poland, in particular the history of the life and valour of Witold Pilecki. Project Participants, independently or in teams of 2–3, shall perform as part of the Project several partial tasks and a final task, which consists in creating a multimedia form – a video recording, podcast or animation, in which they will present Witold Pilecki to the public and answer the question why his character is important for today's world? What values does it entail? Why is it worth getting to know Witold Pilecki's attitude better? Participants will popularise their creation (works made in a team as part of the tasks) in the space of their choice: on the Internet, radio or television, so that as many Americans and / or Canadian residents as possible can discover it. During the Project, Participants receive a package of educational materials from the Institute, they participate in online meetings and perform partial tasks proposed by the Organiser which are to help them in the realisation of the final task. Communication between the Participants and the Project Organiser will take place via the Internet, using e-mail, the Google Classroom platform and Zoom.us. Within their teams, Participants communicate in a way that is allowed in their place of residence in the face of the pandemic situation.
- 3. Detailed rules of the Project can be found in the Guide for Project Participant published on the project website: https://instytutpileckiego.pl/pl/projekty/the-pilecki-project.
- 4. The language of the Project is English.
- 5. An account on the Google Classroom platform administered by the Institute will be used for communication with Participants and as a place to present individual works created by Participants.

- 1. The entity managing and implementing the Project is the Institute, while contacts with the Participants are the task of a coordinator, hereinafter referred to as the "Coordinator", available to Participants in connection with all issues related to the organisation, application and participation in the Project and its course at the following e-mail address: pileckiproject@instytutpileckiego.pl.
- 2. All information about the Project is available on the Institute's website: https://instytutpileckiego.pl/pl/projekty/the-pilecki-project.

Rules for participation in the Project

§ 3.

- 1. Project is aimed at pupils and students living in the USA and Canada. Participants can join the Project individually or by creating a 2–3-person "Pilecki Team".
- 2. If the Participant(s) of the team are minors (under the age of 18), they may participate in the Project subject to the consent of their parent / legal guardian.
- 3. Within the Project, Participants perform partial tasks and a final task, which is to create a multimedia form a video, podcast or animation and subsequently, Participants will spread their creation (Works) in the media of their choice: on the Internet, radio or television, so that it can be discovered by as many U.S. and / or Canadian residents as possible. During the Project, Participants take part in thematic meetings (carried out remotely), according to the agreed schedule, and perform partial tasks.
- 4. Organiser reserves the right to publish selected Participants' works in accordance with the Project's objectives.
- 5. Participation in the Project is voluntary and free of charge.

Project applications and Project duration

§4.

- 1. The application is made via the <u>Google form</u>, in which the Participant provides data including, name and surname, address, e-mail address. Application for participation in the Project is possible throughout the duration of the Project.
- 2. The project starts on 25 February 2021 and will end by 31 July 2021.
- 3. Sending the completed form with the Participant's application is tantamount to joining the Project. The Organiser reserves the right to refuse to accept the application for participation

in the Project within 14 days of its submission – only in exceptional circumstances, such as failure to meet the participation conditions specified in the Regulations.

- 4. By filling out the Participant's application form and submitting (sending) the form via the Organiser's website, the Participant (or, respectively, the parent / legal guardian) declares that they have read the Regulations and accept them. Each participant is required to complete an application form, regardless of whether they are participating in the project individually or as a team member.
- 5. By including the Participant's data in the form and submitting (sending) the form via the Organiser's website, the Participant (or, respectively, the parent / legal guardian) declares that they agree to the processing of personal data contained in the application form on the basis and for the purposes specified in these Regulations.
- 6. Failure to accept the Regulations and the clause regarding consent to the processing of personal data makes it impossible to accept the application form by the Organiser.
- 7. The processing of the applicant's personal data contained in the application and the Project participation form requires the consent of the applicant. Applicants aged 16–18 years shall read the statement (Annex 2) and, after its approval, consent to the processing of personal data to the extent and for the purposes indicated in the Regulations. Processing, to the extent specified in the Regulations, of the personal data of children under 16 years of age requires the consent of the person exercising parental authority (Annex 1), i.e. the parent or legal guardian. The condition for participation in the Project is to immediately send a confirmation of consent to the processing of personal data by, respectively, the applicant or the person exercising parental authority (applies to consent to the processing of personal data of children under 16 years of age) for purposes related to their participation in the Project. Failure to receive such consent makes it impossible to accept the application for participation in the Project. It is preferable to send a confirmation of consent to the processing of personal data for the purposes and to the extent specified in the Regulations by e-mail to the dedicated e-mail address: pileckiproject@instytutpileckiego.pl at the same time, or immediately after sending the participation application form. Consent to the processing of the Participant's personal data in connection with their participation in the Project may be submitted in the content of an e-mail or in a separate statement having the form of a scan with the signature attached to the e-mail. There is no obligation to send a written statement by post, but it is a solution welcomed by the Organiser.
- 8. Annex 1 to the Regulations concerns the consent to the processing of personal data of the Participant a child under 16 years of age, while Annex 2 concerns the consent to the processing of personal data of the Participant aged 16 and above, which applicants are required to read and provide to the Organiser after approval, as indicated in point 7 of the Regulations.
- 9. If the Participants decide to put their image in the Works or other materials, they agree to its placement (recording) and dissemination as part of the published posts and possible further free use by the Organiser, without time and territorial restrictions in the scope related to the Project and operation of the Works and related materials on-line and in printed form, i.e. in all media, communication channels, including the Internet in the fields of use specified in § 6 of the Regulations.

Project Summary

§ 5.

Each Participant who completes the Project final task will receive a certificate of participation in the Project. Organiser also plans to issue certificates for participation in online workshop meetings during the implementation of the Project.

Protection of intellectual property and personal data

§ 6.

Upon placing on the Internet platform of all Works / materials produced jointly by Participants in teams in order to carry out partial and final tasks within the Project, the Organiser shall be granted a free, non-exclusive license unlimited in time and territory to use such Works / materials, hereinafter referred to as "Works", in the following fields of exploitation:

- as to the recording and reproduction entering into computer memory and reproduction by any known techniques, including printing, digital, electronic, on any medium;
- as to the circulation of copies placing on the market of the copies produced in accordance with the point above;
- public sharing of electronic versions of project materials and Works in such a way that everyone can have access to them at a place and time chosen by them, in particular via the Internet, broadcasting and rebroadcasting (wireless or wired, via a ground station or via satellite), in any system, technique or format, video-on-demand, webcasting, simulcasting, and streaming, high definition (HD) and three-dimensional (3D) technology, and as part of any telecommunications services using any systems and devices (including landline and/or mobile phones, desktop and/or portable computers, as well as transfers using all available technologies, e.g. GSM, UMTS, etc., by means of telecommunication data transfer networks),
- performance, exhibition, display, reconstruction and public presentation of project materials / Works in any available form, in particular at exhibitions, workshops, conferences, seminars;
- using the Works (in whole and / or in part) for scientific and educational purposes as part of the Organiser's educational mission, including presenting the Participants' Works in the press, television, Internet, in particular on social networks, website of the Organiser, etc.
- using project materials / Works to inform and promote the activities and statutory tasks of the Organiser,

- along with the right to exercise derivative rights to such works and permit the exercise of derivative rights to third parties, i.e. modification of the Participants' Works, in particular creating their studies, adaptations, translations, editing them and any modification to use the above-mentioned fields of exploitation, including the right to combine with other works; the use includes their exploitation in whole or in fragments.

Adult Project Participants declare that they grant a license in the above-mentioned scope and have the copyrights to the Works and their parts, as co-authors through a written statement constituting Annex 3. On what concerns minor Participants, such a declaration is signed by the parent / legal guardian of the Participant (co-author of the Work), in accordance with Annex 4, and the minor Participant.

 - legal provisions may oblige the Institute to process data for a specified period of time,
 - the period necessary to defend the interests of the Institute.
- 9. Institute informs that Participants have the right to:
 - access their personal data,
 - request rectification of their personal data that is incorrect or supplement incomplete personal data,
 - request the deletion of their personal data,
 - request the processing of their personal data to be restricted,
 - object to the processing of their personal data,
 - transfer their personal data,
 - lodge a complaint to the supervisory body dealing with the protection of personal data, i.e. the President of the Personal Data Protection Office.
- 10. If the personal data of the Participants are processed on the basis of consent, consent to the processing of data may be withdrawn at any time. The withdrawal of such consent does not affect the lawfulness of the processing that was made on the basis of such consent before its withdrawal. The consent may be withdrawn by sending a declaration of withdrawal of consent to the Institute's correspondence address or e-mail address.
- 11. Please be advised that we do not use systems for automated decision making, including profiling.

Final provisions

§ 8.

- 1. These Regulations come into force on the day of their publication on the Institute's website.
- 2. The Organiser reserves the right to introduce changes in these Regulations. Any changes to the Regulations made by the Organiser become effective after their publication on the website of the Pilecki Institute.

§ 9.

In matters not covered by these Regulations, the provisions of Polish law shall apply, in particular the Act of 23 April 1964, the Civil Code and other generally applicable provisions of law.
